

MCCAA WRESTLING REGULATIONS**I. CODE OF CONDUCT**

- A. The NJCAA Code of Conduct (Article XX) and the NJCAA Sportsmanship Policy (Article XVIII) will apply to all MCCAAs contests.

II. QUALIFYING POLICY

- A. Any team sport at an institution having to forfeit 30% of their NJCAA maximum allowable games or dates due to NJCAA or State Association sanctions and/or has not qualified by the conclusion of the last regular season conference game played will not be allowed to participate in post season play.
- B. A single game/match/event in a day shall count as a whole game and/or date of competition. (ex. An ineligible player playing a single game in a softball doubleheader will count as the entire date of competition for the team).

III. DRESS DECORUM

- A. Game attire for all bench personnel, other than uniformed players, must be a college issued warm-up suit or business casual apparel unless weather does not permit.

IV. SOCIAL MEDIA POLICY

- A. Michigan Community College Athletic Association recognizes the prevalence and popularity of online communities. Utilizing cyber media responsibly is an expectation of student athletes. Use of any electronic media as a means for harassment is strictly prohibited. Harassing behavior includes sending text, picture, audio, video or executable electronic code (viruses, etc.) over electronic forums, message boards, social media sites and services, instant messaging or chat services, e-mail, or other Internet or intranet service, and websites. This includes repeated unwanted contact or any stalking or bullying behaviors on any of the aforementioned media.

V. WRESTLING MCCAAs TOURNAMENT

- A. Tournament site:
1. The MCCAAs Tournament site shall be awarded on a two-year cycle.
- B. Colleges wishing to bid for the tournament site shall submit proper forms at the Spring meeting according to MCCAAs guidelines.
- C. Team Selection
1. All MCCAAs teams are required to participate.
 2. The method by which the MCCAAs determines how to seed and draw shall be determined by the participating schools.
- D. Tournament Structure:
1. The tournament will be held the on the fourth Saturday in January.
 2. The MCCAAs champion will be determined by using the current NCAA Wrestling guide.
 3. A minimum of two mats must be available for the tournament.
 4. Official scales shall be available at least one hour prior to official weigh in.
 5. Official clock, scoreboard and riding time clock shall be provided for each mat.
 6. Adequate locker room and shower facilities must be available for the college to be awarded a tournament bid.
 7. Entry fee/registration fee- \$100 per team.
 8. Coaches meeting will be held on Friday evening, the day before the tournament.
- E. Officials
1. Officials will be secured by the host institution.

F. Responsibilities of the Host School/Tournament Manager

1. Athletic trainer on site is required.
2. Provide each competing team with information relating to opponents, site, time, lodging one month before tournament.
3. Organizing the tournament awards ceremony.

VI. AWARDS

1. All MCCAAs- The champion of each weight class will be named all MCCAAs.
2. The coach of the MCCAAs champions will be the MCCAAs Coach of the Year.

VII. MISCELLANEOUS

1. The use of tobacco products by any coach, player, official or other individual involved in the conducting of any NJCAA sanctioned or sponsored regular season or post season play is prohibited within the confines of the playing area. Any individual not in compliance shall be disqualified from further participation in that contest.
